

“KTTI COOL CASH MACHINE” Official Rules
(effective Thursday April 1st, 2021 at 11:59:59pm)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

- 1. CONTEST PERIOD:** Contest begins at 12AM on Thursday April 1st, 2021 and ends on Friday 5-21-2021. (“Contest Period”), excluding weekends during the Contest Period Thursday April 1st, 2021 and ends on Friday 5-21-2021
- 2. HOW TO ENTER:** During the Contest Period, listen weekdays to 95.1 KTTI-FM (“The Radio Station”) between the hours of 7 AM and 7PM MST. During the designated time each weekday, 95.1 KTTI - FM will play a “cue to call/sounder” that will solicit the 95th caller to win \$95.00. Limit one (1) winner per day per promotion. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:01 a.m. (midnight) PST and ending at 11:59:59 p.m. PST. The time clock of the Contest Administrator is the official clock for this Contest.
- 3. ELIGIBILITY:** The Contest is open only to individuals who are legal residents of the United States residing in Arizona in the stations DMA who are 18 years of age or older at the time of entry. Employees, contractors, directors, and officers of El Dorado Broadcasters, LLC or associated companies, Company (“Sponsor”), and the immediate family members (spouse, parent, child, sibling, grandparent, and/or “step” of each) and those living in the same households as such employees are ineligible.
